1. Purpose

This section is taken from Rule 4, sections 10.1 and 10.2.

- 1.1 The purpose of the Student Life Zone is to tackle the issues that affect students' everyday life, creating support structures and campaigning for a better quality of life.
- 1.2 The Student Life Zone is responsible for developing and supporting:
 - (a) Peer to Peer groups, including Nightline
 - (b) Housing campaigns
 - (c) Student Financial Support
 - (d) Student health
- 1.3 The Committee shall operate under the general rules governing Zone Committees as outlined in Rule 4.

2. Membership

This section is taken from Rule 4, section 10.3. It sets out the core membership of the committee as defined by that section.

- 2.1 The core membership of the Zone Committee is:
 - (a) VP Welfare (Chair),
 - (b) Union President,
 - (c) Housing Officer
 - (d) Nightline Officer,
 - (e) Student Life Zone Student Groups Representative,
 - (f) Wellbeing Officer,
 - (g) the additional Sabbatical Officer, selected in accordance with Rule 4, section 6.3(c), and
 - (h) the two Union Councillors, selected in accordance with Rule 4, section 2.2(a).

3. Sub-committees

This section creates sub-committees of the Student Life Zone Committee. Each sub-committee has its own by-law, which sets out how that sub-committee

works. Sub-committees report to and are the responsibility of the Zone Committee.

3.1 Nightline Committee

- (a) The Nightline Officer shall chair the Sub Committee.
- (b) The purpose of the Nightline Committee is to support and develop the operation of the Nightline service.

3.2 Wellbeing Committee

- (a) The Wellbeing Officer shall chair the Sub Committee.
- (b) The purpose of Wellbeing Committee is:
 - (i) To ensure that the student health issues are at the forefront of activity within Student Life Zone.
 - (ii) To ensure that financial health for students is developed as an area of work within Student Life Zone.
 - (iii) To ensure that sexual health awareness is at the fore front of student welfare.
 - (iv) To support the Wellbeing Officer and all other areas of their work – running campaigns, events and building awareness.

4. Sub-groups

This section explains the procedure for creating sub-groups of the Zone Committee for particular tasks.

4.1 The Zone Committee may, from time to time, establish sub-groups to organise or perform a specific activity or activities.

4.2 In order to create such a group, the Zone Committee will approve the terms of reference for that sub-group, to include:

- (a) the membership of the sub-group,
- (b) the chairing of the sub-group,
- (c) the time period the sub-group will be active for,
- (d) any decision-making powers delegated to the sub-group,
- (e) the process by and frequency with which the sub-group shall report to the Zone Committee.

4.3 The Zone Committee may, from time to time:

- (a) vary the terms of reference of a sub-group, or
- (b) dis-establish a sub-group.

4.4 The Zone Committee remains responsible for the work of the sub-group.

4.5 A decision made by a sub-group is valid subject to ratification by the next meeting of the Zone Committee.

5. Meetings

5.1 Sub-committees should meet at least twice per term.

5.2 The Chair shall, with appropriate support, ensure agendas and papers are circulated at least 2 clear working days in advance of meetings.

5.3 Minutes of sub-committees and sub-groups shall be reported to the next meeting of the Zone Committee.

5.4 A sub-committee shall make (and may alter) by-laws relating to the operation of the sub-committee, which shall include provision for a quorum for decision-making of not less than half of its membership. The creation or alteration of a by-law must be approved by the Zone Committee before coming into effect.

6. Elections of Voluntary Officers

6.1 Voluntary Officers of the Zone Committee and the sub-committees are elected at the last meeting of that committee during the summer term.

6.2 Where a Voluntary Officer position is vacant, a by-election shall be held for that position at the next meeting of the committee.

6.3 Elections for Voluntary Officers are held in accordance with the General Meeting Elections By-law issued under section 5.1 of Rule 7.

6.4 The period of office of a Voluntary Officer begins on the first day of July after their election, or if they are elected at a by-election, then on that day.

6.5 The period of office of a Voluntary Officer ends on the last day of June after they take office.

7. Student Groups Representative elections

7.1 An election shall be held for the Student Life Zone Student Groups Representative, usually at the end of the Summer term in each academic year.

- 7.2 Every member of a student group within the Student Life Zone is eligible to stand.
- 7.3 Every student group shall have one vote, which shall be cast by the president of each group (or a person appointed by them for that purpose) on behalf of the group.
- 7.4 The election shall be run in accordance with such by-laws as may from time to time be made by the Democracy Zone Committee.
