#### Overview

#### **SUSU**

SUSU is a large students' union with approximately 70 core staff in addition to around 150 student support staff. Our charitable objectives are to represent and support students as well as providing social, cultural, sporting and recreational activities for students at the University of Southampton; we have an Advice Centre, over 350 clubs and societies and hundreds of academic reps. In addition, we have a bar, coffee shop, two retail outlets and offer weekly evening events.

We are based on the main University of Southampton campus in Highfield.

We are largely funded by a grant from the University of Southampton, to whom we are accountable. Our relationship with the University is strong, and our ambitions and strategy broadly aligned with theirs. However, our role is to represent students and we are a separate, independent charity. We work hard to ensure our relationship with the University is based on honesty, integrity and trust, making it possible to have challenging conversations when we need to.

# **Trustee Role and Responsibilities**

Trustees have a duty to:

- Ensure that SUSU acts in accordance with its charitable objects, Articles of Association, and other guiding documents and, in particular, remains true to its Purpose and Values.
- Help SUSU achieve its objectives and enrich the life of every student.
- Ensure that SUSU complies with all relevant legislation and regulations, including relevant charity acts and education acts.
- Adhere to the Trustee Code of Conduct and the Charity Governance Code.
- Ensure that SUSU does not undertake activities that put its financial stability, members, or reputation at undue risk.

Working closely with the CEO and Senior Leadership Team, the trustees ensure development and delivery of a long-term strategy for SUSU. The Trustee Board is responsible for organisational governance, finances and adherence to SUSU's purpose and values.

## **Time Commitment**

In addition to the full Trustee Board, there are 3 sub-committees of the Board: Audit & Risk, Finance & Resources, and Executive Performance & Reward. External trustees are expected to attend one of these sub-committees and act as Chair to another sub-committee.

All meetings last 1–2 hours, with an extended Trustee Board meeting once a year to include lunch. Meetings are held in person (hybrid attendance is also possible) and generally during normal working hours. Trustees are required to read all papers before the meetings. Optional pre-brief meetings are also set up before Board meetings.

The Trustee Board meets 3-4 times per year and the sub-committees meet 2-3 times per year. **Total time commitment from trustees is likely to be 4-5 hours per month**.
